Two US Navy sailors were charged on Thursday with providing sensitive military information to China - including details on wartime exercises, naval operations and critical technical material. The two sailors were charged with similar moves to provide sensitive intelligence to the Chinese. But they were separate cases, and it wasn't clear if the two were courted or paid by the same Chinese intelligence officer as part of a

larger scheme. Federal officials at a news conference in San Diego declined to specify whether the sailors were aware of each other's actions.

Both men pleaded not guilty in federal courts in San Diego and Los Angeles. They were ordered to be held until their detention hearings, which will take place August 8 in those same cities. US officials have for years expressed concern about the espionage threat they say the Chinese government poses, bringing criminal cases in recent years against Beijing intelligence operatives who have stolen sensitive government and commercial information, including through illegal hacking. US officials said the cases exemplify China's brazenness in trying to obtain insight into US military operations.

HZL Won't Borrow to Keep Paying Dividends, says CEO

Misra says no intention to revive plan to buy parent Vedanta's global zinc biz

New Delhi: Hindustan Zinc Ltd (HZL) Ewon't borrow to keep paying dividends and its financial heft hasn't been under-Emined by a series of generous payouts over the past one year or so, the company's chief executive Arun Misra said.

The government is keeping an eye on HZL's dividends, a senior official had told ET last month, adding it would raise a red -flag when it feels the company is using its borrowing proceeds to extend dividend to parent Vedanta and other shareholders.

In an interview to ET, Misra also made it clear that HZL doesn't intend to revive its now-lapsed January proposal to buy parent Vedanta's global zinc business. The \$2.98-billion cash deal proposal had rattled the government, the most important minority shareholder in HZL with a 29.54% stake. The Centre had also questioned the deal valuation.

"The LME (London Metal Exchange) prices for metals are low and let's first figure out ways to protect profitability. We have distributed dividends and our cash positions have to be much healthier if we have to (plan to) buy it (Vedanta's global zinc assets) again," Misra said.

"As far as HZL is concerned, in the worst possible scenario of \$2,400 per tonne (zinc price on the LME) and the cost of \$1,200, we still have a 50% EBITA (earnings before interest, taxes, and amortization) margin. So if we do a \$4-billion business a year, we will at least get \$2 billion in EBITA," he said.

'Our cash and cash equivalents are roughly the same as the debt. So, practically speaking, we are a zero-debt company. And any company of our size can go to at least 1:2 (equity-to-debt ratio). So, the balance sheet is strong," Misra said.

As of June 30, HZL's consolidated gross investments and cash & cash equivalents stood at ₹9,709 crore, against total outstanding borrowings of ₹9,330 crore. The investment and cash & cash equivalents. however, were to the tune of ₹24,254 crore as of June 2022

On whether the company would borrow to keep extending dividends, Misra said: "As the CEO, I am not in favour of it, nor are the directors on our board in favour of it."

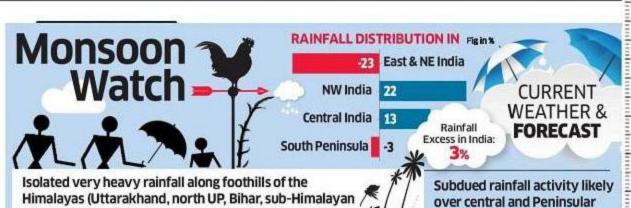

संबंधित है, जबकि गोदरेज प्रॉपर्टीज का कारोबार ज्यादा विविधीकृत है और उसके राजस्व में एमएमआर का योगदान ४० प्रतिशत है।

जहां जन तिमाही के नतीजों के बाद प्रबंधन की प्रतिक्रिया सकारात्मक थी, वहीं तिमाही में बुकिंग के आंकड़े भी

उदाहरण के लिए, ओबेरॉय रियल्टी के लिए वित्त वर्ष 2024 की पहली तिमाही सुस्त रही, क्योंकि अल्पावधि में नई पेशकशों के अभाव की वजह से उसे बिक्री पूर्व आंकड़ों में कमजोरी का सामना करना पडा। पहली तिमाही में कंपनी की बिक्री 46 प्रतिशत तक घटकर 1.5 लाख वर्ग फुट और मूल्य 37 प्रतिशत तक घटकर 476 करोड़ रुपये रह गया।

दूसरी छमाही में कई नई पेशकशों की योजना बनाई है। कंपनी वित्त वर्ष 2024 की दूसरी छमाही में 12,000 करोड़ रुपये मूल्य की परियोजनाएं शुरू करेगी जिससे उसे वृद्धि दर बढ़ाकर 74 प्रतिशत पर पहुंचाने में मदद मिलेगी।

हालांकि यह सकारात्मक है, लेकिन मई में उसके निचले स्तरों से 24 प्रतिशत की वृद्धि अल्पावधि बढत को सीमित कर संकती है।

मोतीलाल ओसवाल रिसर्च का कहना हैकि यह शेयर अपनी कल नेट ऐसेट वैल्यु (एनएवी) के मुकाबले 30 प्रतिशत ऊपर और अपनी रेसिडेंशियल एनएवी की तुलना में 60 प्रतिशत ऊपर कारोबार कर रहा है, जिससे अनुमान लगाया जा सकता है कि कंपनी की संभावित वृद्धि का काफी हद तक असर दिख चुका है। ब्रोकरेज ने इस शेयर की रेटिंग घटाकर 'न्युट्रल' कर दी है। गोदरेज प्रॉपर्टीज ने भी 2,250 करोड़ रुपये का सुस्त बिक्री-पूर्व आंकड़ा दर्ज किया है, जो एक साल पहले की अवधि

की तुलना में 11 प्रतिशत और तिमाही आधार पर 44 प्रतिशत कम है।

बिक्री का करीब 80 प्रतिशत हिस्सा मौजुदा परियोजनाओं से जुड़ा हुआ है और नई पेशकशें 19 लाख वर्ग फट के बिक्री योग्य क्षेत्र के साथ तीन परियोजनाओं तक सीमित हैं। वहीं 23 लाख का बिकंग एरिया सालाना आधार पर 21 प्रतिशत और तिमाही आधार पर 57 प्रतिशत घटा है।

भले ही जून तिमाही में बिक्री सुस्त रही, लेकिन कंपनी ने नई पेशकशों की मदद से वित्त वर्ष 2024 में पूर्व-बिक्री 14,000 करोड़ रुपये पर पहुंच जाने का अनुमान जताया है।

आईसीआईसीआई सिक्योरिटीज का मानना है कि कंपनी के लिए ऋण स्तर पर नजर रखे जाने की जरूरत है। जहां कंपनी सकल बिक्री बुकिंग पर दबदबा बनाए रख सकती है, वहीं उसे मौजूदा और नई परियोजनाओं के लिए भूमि लागत का वहन लगातार करना होगा।

ब्रोकरेज ने पिछले तीन महीनों में शेयर कीमत में बड़ी तेजी के बाद इसकी रेटिंग 'होल्ड' से घटाकर 'बेचें' कर दी है। अपने प्रतिस्पर्धियों के विपरीत, मैक्रोटेक डेवलपर्स ने जुन तिमाही में बुकिंग मे 17 प्रतिशत तेजी दर्ज की, भले ही नई पेशकशों की रफ्तार धीमी बनी रही। कंपनी ने वित्त वर्ष 2023 से वित्त वर्ष 2025-26 के लिए बुकिंग में सालाना 20 प्रतिशत की वृद्धि का अनुमान व्यक्त किया है।

जहां कंपनी के लिए वित्त वर्ष 2023 में बुकिंग का आंकड़ा 12,060 करोड़ रुपये का रहा, वहीं उसने वित्त वर्ष 2024 में 14,500 करोड़ रुपये की बिक्री का लक्ष्य रखा है। नई परियोजनाएं जुड़ने से बुकिंग 17,500 करोड़ रुपये रहने का अनुमान है।

एएमसी रीपो क्लियरिंग के आगाज के बाद सुस्ती

बाजार नियामक सेबी समर्थित और परिसंपत्तियों प्रबंधन कंपनियों की फंडिंग के जरिए स्थापित सीमित मकसद वाले क्लियरिंग कॉरपोरेशन (एलपीसीसी) एएमसी रीपो क्लियरिंग (एआरसीएल) की शुरुआत के समय काफी वादे किए गए थे। हालांकि तब से इस प्लेटफॉर्म पर कोई ट्रेड नहीं हुआ है। जब वित्त मंत्री निर्मला सीतारमण ने 28 जलाई को इस प्लेटफॉर्म का उदघाटन किया था तब 12 ट्रेड के जरिये यहां 480 करोड़ रुपये का कारोबार दर्ज हुआ था। सूत्रों के मुताबिक, उद्योग के प्रतिभागियों के बीच सीमित मकसद वाले क्लियरिंग कॉरपोरेशन का विचार पूरी तरह से अपनी जगह नहीं बना पाया है और एआरसीएल कंपनियों, प्राइमरी डीलरों और अन्य भागीदारों के साथ बातचीत कर रही है।

सबूत के अभाव पर सेबी की आलोचना

पिछले हफ्ते बाजार नियामक सेबी को उस मामले पर प्रतिभृति अपील पंचाट (सैट) की आलोचना का सामना करना पड़ा, जिसमें सेबी

ने एक दशक से ज्यादा पहले के मामले में सख्त सजा दी थी। सेबी के पूर्णकालिक सदस्य की तरफ से अक्टूबर 2021 में पारित आदेश को निरस्त करते हुए पंचाट ने कहा, कारण बताओ नोटिस का आधार गलत है और यह उचित सब्त पर आधारित नहीं है। हमने पाया कि किसी नोटिस पाने वाले के खिलाफ आगे कार्यवाही कुछ ठोस सबतों के आधार पर होना चाहिए, जिसका अभाव नजर आ रहा है। यह सिर्फ अपर्याप्त सबत का मामला नहीं है बल्कि यहां सबूत का ही अभाव है।

एसबीएफसी, कॉनकॉर्ड का जीएमपी बेहतर

एसबीएफसी फाइनैंस और कॉनकॉर्ड बायोटेक का आईपीओ वैसे तो दो दिन बाद बंद होगा. लेकिन अगर ग्रे मार्केट प्रीमियम पर नजर डालें तो यह शानदार दिख रहा है। 1,025 करोड़ रुपये के एसबीएफसी के आईपीओ को 6.3 गुना बोली मिली है और इसका जीएमपी 65 फीसदी से बढ़कर 70 फीसदी पर पहुंच गया है जबकि बाजार में उतारचढ़ाव हो रहा है। इस बीच, राकेश झुनझुनवाला फैमिली समर्थित कॉनकॉर्ड बायोटेक का शेयर का जीएमपी 25 फीसदी है। संकलन : खुशबू तिवारी
