प्राधान्य आणि अंत्योदय कुटुंबीयांसाठी पिवळे काई वितरित केले जाते. साड्या मात्र अंत्योदय लाभाध्यनाच मिळणार आहेत. त्यामुळे प्राधान्य कुटुंबातील लाभार्थीही साड्यांसाठी दावेदारी करतील. साड्यावाटपाची प्रक्रिया ई-पॉस मशिनद्वारे केली जाणार आहे. साहजिकच लाभार्थी उपस्थित राहतील. साड्यांच्या रंगांवरून स्वस्त धान्य दुकानदारांना मोठा त्रास सहन करावा लागणार आहे. त्यामुळे शासनाने एकाच रंगाच्या साड्या उपलब्ध करून घाव्यात.

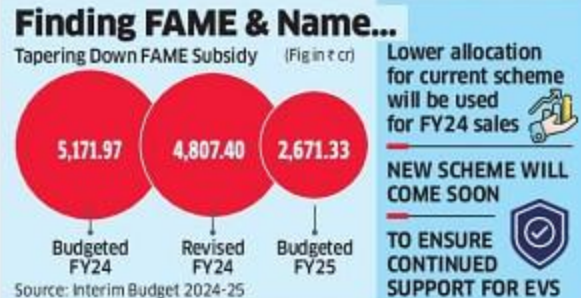
New Scheme Soon to Continue EV Push

New Delhi: India will soon unveil a new scheme to incentivise electric vehicle purchases and expand charging infrastructure in line with the finance minister's interim budget announcement to accelerate the adoption of eco-friendly transportation. Officials in the Ministry of Heavy Industries (MHI) said on Friday that the allocation of ₹2,671.33 crore under the Faster Adoption and Manufacturing of (Hybrid &) Electric Vehicles in India (FAME India) Scheme for fiscal 2024-25 will be utilised to subsidise EVs sold till March 31, 2024.

The government had earmarked ₹5,171.97 crore under FAME India in the budgetary estimates (BE) for fiscal 2023-24 but scaled it down to ₹4,807.40 crore in the revised estimates (RE). According to MHI, ₹1980.83 crore has been disbursed under FAME II in FY24.

"Eligible EVs sold till March 31 will be subsidised



from the FY25 budgeted amount. A new scheme also under the aegis of the MHI will be announced for sales made from April 1 onwards," an official privy to the plans told ET, adding that the allocation and intended beneficiaries will be finalised soon.

The government supports EVs and chargers by subsidising them under FAME India scheme, which is currently in its second iteration (FAME II). The programme aims to spur localisation of EV components while also boosting sales. Manufacturers sell disco-

Fiscal Prudence Unlikely to Impact India's Sovereign Rating: Fitch

New Delhi: Fitch Ratings on Friday said the slightly faster pace of fiscal deficit reduction does not significantly change India's sovereign credit profile but the government's emphasis on deficit reduction will help to stabilise the debt-to-GDP ratio over the medium term.

"The budget was broadly in line with our expectations, though with a slightly faster pace of deficit reduction, from when we affirmed India's 'BBB-' rating with a stable outlook in January," Fitch noted.

"The targeting of 5.1% of GDP deficit in FY25 demonstrates that the government is strongly committed to reducing deficit and achieving its deficit target of 4.5% by FY26, while maintaining a critical focus on much-needed infrastructure development," Fitch said.

Middle-income Housing to Get a Big Boost

Focus on infrastructure & connectivity also expected to spur realty demand

Mumbai: Housing for the middle-income section is expected to get a push with the government proposing to start a scheme to help deserving people in this income group living in rented houses, chawls, slums and unauthori-

sed colonies to buy or build their own houses. The focus on improving infrastructure and connectivity will also spur creation of demand for residential and commercial real estate in the country. In the interim budget on Thursday, finance minister Nirmala Sitharaman also announced support for the construction of an additional 20 million homes in the next five years under the Prime Minister Awas Yojana-Gramin (PMAY Rural). The PMAY budgetary allocation has also been increased to ₹80,671 crore for FY25 from ₹79,590 crore in FY24.

"The announcement to build 2 crore additional houses in the next five years to cater to growing demand and announcement of a housing scheme to help deserving sections of the middle class to buy or build their own houses is encouraging and will aid in the growth of the housing market," said Boman Irani—president, CREDAI National. The ₹1 lakh crore fund corpus for research in sunrise sectors announced by the FM is expected to boost innovation powered by the private sector and demand for commercial properties.

Solar Subsidy for Homes Likely to Go Up to 60%

New Delhi: The government is looking to increase the subsidy for rooftop solar projects for households to 60% of the capital cost from 40% currently, aiming at lower and lower middle class, power minister RK Singh said on Friday.

"We intend to increase the subsidy and probably it would be around 60%. Right now, it is about 40%," Singh said. FM Nirmala Sitharaman in her budget speech had stated that 10 million households will be enabled to get up to 300 units of free electricity under the Pradhan Mantri Suryodaya Yojana — the new solar rooftop scheme. "The scheme will focus on those households whose consumption is less than 300 units, which gener-

ally includes the economically weaker section. For them, going and applying for a loan is a problem," Singh said.

Power sector public enterprises will form SPVs in states assigned to them for implementing the projects. ET had reported on January 15 that the government is planning to enlist PSUs such as NTPC, NHPC, Power Grid and SJVN, along with four others for implementing the rooftop solar scheme, with REC as the nodal agency.

SPVs will reach out to those having up to 3kW of load and the 40% non-subsidised portion of the capital cost would be loaned by the SPV. The excess power units that will be generated through the rooftop solar project on such households, monitored through virtual net metering, will go towards paying off the loan by the SPV.

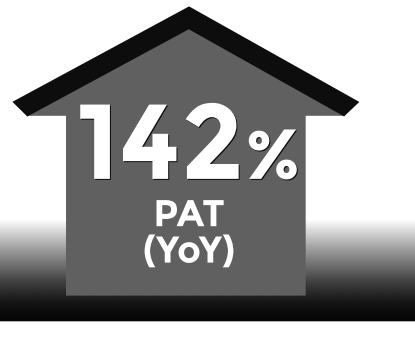
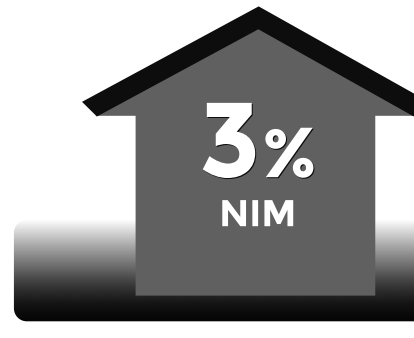

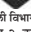
